

Registration Procedure for Electronic Balloting Deadline Tuesday, April 7th

Per C&L, Past Masters (PM) may cast their ballots for elected Grand Lodge offices (Title 3, Article IV, Section 2, Part 1) using an Internet connection. This article will outline the process you must follow in order to vote at a location other than the Balloting & Registration Room at the Annual Communication in Atlantic City. You may vote from any device (desktop, tablet, mobile) that has an Internet connection and Web browser.

You MUST REQUEST AN OFF-SITE BALLOT by PRE-REGISTERING.

To pre-register, you must send an e-mail by 11:59 pm Eastern Time, Tuesday, April 7th, 2020 to **GLNJVOTING@GMAIL.COM** containing:

- Your Full Name
- Your E-mail Address
- Your Member Number (found on your dues card or through your Lodge Secretary)
- NJ Lodge Name/Number

Once your eligibility is verified by the GL office (which may take a few days), you will receive a confirmation email stating that you have successfully registered. Then, on the morning of Wednesday, April 22nd, you will receive an email with an encrypted link that will take you to the appropriate webpage to vote. This email will also contain additional information and instructions. Remember, registration for off-site voting will close at 11:59pm Eastern Time on Tuesday, April 7th, 2020.

Balloting will begin at approximately 12:00 noon on Wednesday, April 22nd until sometime between 9:00am and 10:00am Thursday, April 23rd (all times Eastern). Once balloting starts, an email will be sent to those who have registered reminding them that the ballot is now open. Offsite balloting may be done at ANY TIME while balloting is open in Atlantic City. Please note that the times for the start and end of off-site voting are variable depending on when the Grand Master starts and stops balloting on-site. Off-site balloting will end at the same time as on-site balloting. Please do not take a chance and wait until the last minute - vote any time before 9:00am Thursday!

You may request an off-site ballot if you are a PM of any lodge in a recognized jurisdiction and a member in good standing of a Lodge under the jurisdiction of the Grand Lodge of New Jersey, F&AM. Please note that the WM, SW and JW must cast the vote assigned to their office on-site (per C&L). If the WM, SW or JW is also a PM (previous year) and they are not able to attend the Annual Communication, they may only cast their PM vote off-site and must follow the procedure above to register for that ballot.

Statement:

It expands the definition to say, "any of a group or board of persons appointed or elected to manage the affairs of an institution or organization". In accordance with this definition, the Grand Lodge By-Laws states, "The Trustees shall have the responsibility to manage the business affairs of the Grand Lodge".

The Grand Lodge is your Grand Lodge, made up of you the Brethren, and your lodges. It exists to establish and maintain a sense of normalcy and consistency for its members and lodges, and to provide a support mechanism tying New Jersey Freemasonry together. In doing so, it is a business entity, with approximately 16,000 members. Within this structure there are expenses to be incurred, revenues assessed to pay those expenses, and assets, such as investments, to

The Grand Lodge Trustees are empowered to oversee this business entity, independent of its elected officials, who are not members of the Trustees With my extensive business and Masonic background, I was specifically recommended to, and appointed by, the Grand Master to fill a vacancy in the Trustees in September. This opportunity has allowed me to have a direct and immediate impact on the proceedings of the Trustees in providing a new and business-based voice to the Trustees

regarding several critical financial matters

During my entire work and Masonic careers, I have had to set reasonable expectations, set rational and realistic processes to obtain those goals, and to establish relationships to ensure those goals are achieved. Within a mixed framework of multiple personalities and commitment levels, this work has, by necessity, included the development of budgets, the monitoring of periodic financial and manpower results, and the implementation of adjustments when actual results do not meet expectations. All of these experiences are relevant to the position of Grand Lodge Trustee.

Despite the good and well-intentioned inclinations of all parties involved in laudable pursuits, there has always been, and there will always be, disagreements. In both my professional and Masonic careers, I have been able to find the consensus, the common ground, and very importantly, the transparency necessary to make an entity's business model work.

I have been Worshipful Master twice, District Ritual Instructor three times, Secretary to the Grand Master, and District Deputy Grand Master for three years, as well as having been a member of the Grand Lodge Tax, Audit and Ritual Committees. As mentioned earlier I have also recently had the good fortune of being a Grand Lodge Trustee for the last six months. I know and understand how Grand Lodge works. I know and understand how lodges work. I know and understand the challenges that face both Grand Lodge and the individual lodges. The position of Grand Lodge Trustee is not one that I take lightly, and I now ask you for your support in continuing the Mission I was requested to assume as a Trustee in September, representing you as an elected member of your Grand Lodge Trustees.



I am also a 32° member of the Ancient Accepted Scottish Rite, Valley of Northern New Jersey, Northern Masonic Jurisdiction and a proud supporter of Shriners Hospitals for Children. I was recently recognized by my Lodge for my excellence in Ritual, Programs and support of the Brethren

and Lodge.

Statement: The Grand Lodge of New Jersey has supported a Masonic Home in Burlington in various forms since the late 1890s. During the Great Depression, the Grand Lodge formed the Masonic Charity Foundation as a non-profit for general charitable purposes. Until recently, the Foundation was focused primarily on long-term and short-term nursing care, physical therapy, retirement apartments and hospice care.

Beginning in 2014, the Foundation began converting nursing home beds into retirement apartments and embarked on a major project to renovate its facilities and to construct 66 new duplex retirement

cottages to provide "active senior housing." Costs for the renovations and expansion, including lost revenue during and following the renovations have reduced the net worth of the Foundation by nearly \$25 Million or 25%. During this same time period, the Foundation's revenue has also declined by over 25%. Although the trend for occupancy of the cottages and apartments is encouraging, the Foundation's current business model is unsustainable and may not represent the best use of the Brethren's charitable funds. As an experienced non-profit board member and an attorney with 30 years of experience in real estate projects, I would be a valuable addition to the Charity Foundation Board as it continues to steer the Foundation towards financial sustainability.


