We often hear disagreements as to "Blue Lodge first" versus "Grand Lodge first". However, there is a symbiotic relationship between Blue Lodge and Grand Lodge, and one cannot exist without the other. And I pledge to you, my utmost efforts in working with the future Grand Masters and the lodges to strengthen both the lodges and the Grand Lodge, to build on recent successes, and to move the fraternity forward.

Freemasonry is a business, both at the Blue Lodge level and the Grand Lodge level. My professional background as a CPA has given me the important skill sets to successfully bring about leadership and consensus in the key management and executive positions within our Fraternity. In a variety of positions I have been in leadership roles within our Grand Jurisdiction since my first Grand Lodge appointment from our 2001 Grand Master, the late MW David A. Chase. This includes

- District Ritual Director 3 times for a total of more than 8 years, for 2 Districts
- District Deputy Grand Master for 3 years
- Secretary to the Grand Master, a 4-year commitment and excellent training experience for Junior Grand Warden through Grand Master
- Grand Lodge Trustee for the last 6 years, starting as a one-year replacement appointment by Grand Master. MW Gregory J. Scott, followed by 2 reelections to 2 additional terms
- Chairman of the Audit Committee for more than 15 years

- Member for more than 10 years and current Vice-Chairman of the Ritual Committee; and
- · Member of the Temple and Lodge **Finance Committee**
- Member of the State of the Craft Committee.

Grand Lodge Trustee

All of these positions have had me traveling throughout the state, with the opportunity to talk to the Brethren - experienced and new, active and not-so-active, and multigenerational members - and to hear from them why they joined, what they see in Freemasonry, what they would like to see change, and their concerns for the future.

All of these positions required the demonstration of both up-front and visible leadership, as well as active, behind-the-scenes management. As a summary of key results, I point out the following:

- As a DRI and a member of the Ritual Committee, I take pride in having been able to teach, not just dictate, our ritual work.
- As a DDGM, I enjoyed the success of leading a well-run District, while at the same time, have had to use my professional skills as a manager, in ensuring lodge monitoring and reporting requirements were met, that lodge programs were well run, that coordination and consensus was maintained between lodges in the District, and, when necessary, that unmasonic behavior was properly, judiciously, and reasonably addressed.
- As Audit Committee Chair, I led the Committee's search for a new CPA firm for the Grand Lodge audits and tax return preparation, ultimately recommending to the Grand Lodge Trustees a CPA firm who

could provide more timely and cost effective audit and tax services.

- As a member of the Audit Committee and the Temple and Lodge Finance Committee, I have had the opportunity for several years to help approximately 10-12 lodges per year throughout the state in preparing their lodge annual Fiduciary Reports.
- As a Grand Lodge Trustee, including terms as Vice President and President, I was able to be part of a team, elected by you, that addressed concerns of the Brethren, particularly in the areas of transparency, budgeting, and cost effectiveness, in a timely and prudent manner. Positive results have included in the last few years, the following:
- Audited financial statements and tax returns of the Grand Lodge are now prepared more timely and cost effectively, and are now available on Grandview.
- The Grand Lodge Trustees are now included as an integral part of the annual Grand Lodge budget process, and those budgets are now available on Grandview.
- As part of the annual budgeting process, the Grand Lodge Trustees addressed the ever-increasing costs and potential tax implications of the Past Grand Masters jewels, and recommended revisions to that program which were then voted upon by you, the voting members of Grand Lodge, at our 2024 Annual Communication.
- All expenditures of the Grand Lodge office are now reviewed as part of the monthly Grand Lodge Trustees meetings, and the minutes of those meetings are now available on Grandview.

We are turning the corner where new membership is surpassing declining membership due to deaths. Although we are still losing membership due to nonpayment of dues, these challenges are not insurmountable. Communication with existing membership is vital in the reduction of NPD membership. More importantly, addressing the **relevance** of Freemasonry

challenges, particularly regarding membership.

to its membership is critical to the solution of this problem. I recommend looking into the relevance issues of Freemasonry regarding "what led a person to join", "what has changed in his relationship with the Fraternity", and "what was it that once made Freemasonry relevant to him, his family and his community, but is now missing"? Answer these questions, applying new 21st century methods to reinvigorate prior programs and processes that once worked, as well as to find new solutions, and we start bringing back Freemasonry to our members and our communities.

I have recently been blessed with 2 new grandsons - my first grandchildren. I joined the Order of DeMolay when I was 13, the age requirement at that time. I then joined Freemasonry at the age of 21, as a fourth generation Freemason. Despite the recent, good-intentioned jokes about whether or not my Grandsons' petitions for DeMolay and Masonry are already signed, I can at least say that it is my intention to do whatever I can for NJ Freemasonry, to ensure that our great Fraternity is around and healthy in the near and distant future. Since its inception, Freemasonry has always been relevant to its members, family, and community, and it should be, and needs to continue to be, relevant to our future.

Better member services have remained at the top of my priorities list. Now, when you call the Grand Lodge Office, if the call is not answered by staff, it is automatically forwarded to my cell phone. Your inquiries and your Lodge's questions and concerns are now promptly handled.

I also promised you would once again receive paper dues cards. Those are now available, as are the virtual dues cards on both the Grandview and the Amity applications.

I am currently working on a dues-paying system in which the dues, in their entirety, go directly to the Lodges. You might remember that Grandview has a dues-paying option in which the dues go to Grand Lodge, and after the assessment is taken, the balance is forwarded to the Lodges. I stand firmly against this process. All dues payments must always go directly to the Lodges, and assessment payments must remain part of the Annual Report.

Using Grandview, the Lodge Secretaries can now enter petitions directly. Soon, this process will be further streamlined for greater efficiency and privacy. Petitioners will be able to initiate their own background checks, eliminating the need for the Lodges to mail a check to the Grand Lodge Office. Petitions will be emailed in.

I do not believe there is any reason whatsoever for Social Security numbers to be sent to the Grand Lodge office. This is an unnecessary risk and a possible Grand Lodge liability.

I am also working on raising funds for the

Grand Lodge. I am working on attaining a raffle license for the Grand Lodge. Together, we have and will accomplish many great things, and it is an effort that can only be accomplished with a team effort.

My promise to you, my brothers, is that I will continue to advocate for your needs and concerns while also ensuring that the Grand Master, the Elected Line, and the Grand Lodge Trustees receive all the support they need to fulfill their duties. I have served my Lodge as Secretary for 20 years, so I know what you expect from the Office of Grand Secretary.

We also changed the scholarship process by migrating the application online and consolidating the form to a single one that covers all the charity's scholarships. We have also extended the eligibility requirements to include nieces and nephews.

I am now seeking your support in my bid for election to the Board of Trustees of the Grand Lodge. My educational background, combined with my record of Masonic leadership, offers a unique knowledge and skill set tailor-made for approaching this role with rigor, prudence, and creative insight

I believe that the one word that describes my approach to organizational leadership is "innovator". From my professional career, to the halls of higher learning and most recently to the Masonic Charity Foundation, I have always sought to find good and creative solutions and approaches to meeting challenges and doing things better.

When I became chairman of the Charity's Outreach committee two years ago, there were no expressed concerns, but I was able to identify areas for improvement.

money awarded rose by more than 1,000%. At AT&T no one said there should be a way to help customers who needed to be reached, even when they were away from their phone (this was in the 1990's before mobile phones). But I analyzed a future unarticulated need and invented a new mobility service. At the time, this was heralded as so forwardthinking that it was featured at Disney's EPCOT park in their Innovations Center. And when none of the existing AT&T support organizations knew how to work with a hybrid service, I built customer care, billing, and marketing teams specific to the new service. Of course, having a modular organization made it easy for AT&T to sell the service out from under me. But they had to pay for the privilege. So my severance package allowed me to be a retiree before I was 44 years old.

When I was a professor of statistics at Rutgers, no one was attempting to change traditional teaching methods, but I chose to make the subject clearer and less intimidating, much to the appreciation of my students. (See my Facebook posting on the comments students gave on my evaluations). I still go back and read them whenever I need a lift.

We have north of 11,000 Freemasons in the state. Do you see them? It is you who are the true working Masons. You read about the candidates for office. You attend your lodge meetings and DLIs. You are the ones who are there to support your brothers. You have to be present to have an impact. I will be there. You have seen me at your receptions. You have seen me at your GLIs. And you have seen me in your lodges. While a Charity board trustee, the handful of meetings that I missed were either due to family vacations or not getting discharged

from the hospital in time. Stage four cancer will sometimes do that to you. But nothing less kept me away. I sat in meetings with wound vacuums running under my suit and portable IV pump, feeding me antibiotics, but I still attended.

Having been a trustee, I know the time, the commitment, and the effort it takes. Because that is what you deserve. Someone who is not distracted by other major Masonic duties and can give their full attention to the business of the fraternity. I asked for your support last year, and in return, I fulfilled the promises I made to you. This year, I ask for your support to elect me as a trustee of the Grand Lodge so that I can work on behalf of the you the Bretheren in strengthening and improving our beloved fraternity for the next generations! There is much work to be done and I am proven in getting it done!

Two Perpendicular Parallel Lines

The point within a circle embordered by two perpendicular parallel lines, with the Holy Bible resting on the circle, is one of the most recognizable symbols in Freemasonry. It is also one which always raises a question. How can two lines be both perpendicular and parallel?

Anyone that has ever sat through a basic geometry class knows perpendicular and parallel lines are opposite. They are each defined mathematically as follows:

Perpendicular lines: "Perpendicular lines are lines that intersect and form right angles."(1)

Parallel lines: "Two lines are parallel if they are in the same plane but never intersect." (2)

If perpendicular and parallel lines are geometrically opposite why does our ritual refer to these two lines as both perpendicular and parallel? Clearly this is a contradiction! There are two possible explanations for this inconsistency.

First, it is possible that the word perpendicular refers to the two tangents perpendicular to the diameter of the circle. A tangent is a line that touches the edge of a circle once. The diameter would pass through the point. In other words, both lines, or both tangents, form two 90-degree angles with the diameter of the circle.

Second, a more antiquated definition of the word perpendicular meant "straight up and down," "vertical," or "nearly vertical." For example, the perpendicular face of the mountain, or the perpendicular mast of a ship. The word derives from Latin. Per (through) + pendere (to hang) forms perpendiculum (plumb line). Our ritual makes much more sense if we apply this antiquated definition of the word, "two hanging parallel lines," or "two vertical parallel lines." Additionally, the word pendant derives from the French verb pendre "to hang," which also derives from the Latin pendere. After all, a pendant hangs around a person's neck.

Many masons do not understand that the use of the word perpendicular in our ritual is either referring to the two tangents perpendicular to the circle's diameter or that the ritual is using an antiquated definition of the word. The latter is more likely. This lack of understanding in the past has even caused the Grand Lodge of New Jersey to remove the word "perpendicular" from the ritual altogether. However, Grand Lodge has recently added it back in.

Our masonic teachings direct us to subdue our passions and improve ourselves through masonry. What better way to improve ourselves than by studying our ritual? However, sometimes when we examine the ritual through a modern lens, we unintentionally, leave the lens cap on.

TITLE THREE, ARTICLE IV: Grand Lodge Meetings and Elections Section 1. Meetings

The Grand Lodge shall meet statedly once a year *in November*, for the *annual* communication of all the lodges, *the election and installation* of Grand Lodge officers, approval of the budget, report of committees, and such other business as may be necessary for the efficient governance of the Fraternity.
- b) Communication on Legislation. The Grand Lodge shall meet once a year in May, but no later in that month than May 15, for the specific purpose of voting on any proposed change in Grand Lodge dues, and any proposed legislation which alters or adds to Title Four, Articles I through XII of these By-laws and Regulations.
- c) Prior to the May Communication on Legislation and dues provided in subparagraph b), the Grand Lodge shall hold a minimum of two town hall meetings, one in the northern part and the other in the southern part of the State, for the purpose of allowing the members to express their opinions, concerns, and offer amendments. Final draft of legislation to be voted on shall be published to the membership no less than ten (10) days prior to the May Communication.
- d) *Occasional Grand Lodge* communications, as business may require, *shall take place* at such times and places as Grand Master shall appoint.

Interpretive Statement:

Proposed legislation is very important to the governance of our Fraternity and any proposed changes to legislation should be dealt with much thought and consideration. At our Annual Communication we have lots of other business to contend with and by dealing with any proposed legislation in the current manner is generally rushed in order to stay on a tight schedule. Switching our voting on proposed legislation to the month of May would allow us more time to consider these proposals wisely. In addition with adding the Town halls the Brothers should be well informed before they vote on changes that could affect our Fraternity for years to come. Voting on any proposed Grand Lodge dues increase in May will give time for all the Lodges to adjust their Lodge dues before the New Year if there is a need to do so.

TITLE FOUR: GRAND LODGE BY-LAWS

Section 9. Fees, Dues & Assessments

Part 5. Exemption from in one lodge in this jurisdiction
to any lodge in this jurisdiction

Current Legislation: Part 5. Exemption.

A member who has paid dues for 25 years consecutively in **one lodge** in this jurisdiction may be exempted from future payment in whole or part by a majority ballot. This exemption will not bar the member from admission to the Masonic Home upon proper application.

Proposed Legislation: Part 5. Exemption.

A member who has paid dues for 25 years consecutively in **any lodge** in this jurisdiction may be exempted from future payment in whole or part by a majority ballot. This exemption will not bar the member from admission to the Masonic Home upon proper application.

Interpretive Statement:

As stated, the change would apply to any member who was Initiated, Passed, and Raised in one lodge in this jurisdiction during his Masonic Career. This change could also apply to any member who was Initiated, Passed, and Raised in one lodge in this jurisdiction who has transferred membership into another lodge in this jurisdiction. This change would also apply to any member who was Initiated, Passed, and Raised in another Masonic Jurisdiction who has transferred membership into any lodge in this jurisdiction. Transferred in this case refers to the process where a member of one lodge has petitioned another lodge for dual membership, been accepted for dual membership by that lodge, and has requested a demit from his previous lodge. In the case of a Merger or Consolidation, an exemption if granted in one lodge prior to a merger or consolidation, it would be carried over into the new lodge. In Masonry, a Member's Birth, Initiation, Passing, and Raising dates follow him through his Masonic travels from birth to death when he is called on high by the Grand Master of the Universe.

As worded above, there is no mention of the amount for actual dues paid in any lodge and with changing careers, a Mason may have changed his location and joined another lodge due to circumstances related to his life outside of Masonry.

TITLE FOUR, GRAND LODGE BY-LAWS ARTICLE III: Communications and Elections Section 4. Administrative Proceedings Part 4. Amendment of Grand Lodge By-Laws

Current Legislation:

Part 4. Amendment of Grand Lodge By-Laws.

a) Required Procedure. No alteration or addition shall be made to Title Four, Articles I through XII of these By-laws and Regulations unless proposed in writing, signed by a member of the Grand Lodge, and published in the New Jersey Freemason, and shall require a majority vote for adoption.

b) Procedure Without Publication. An amendment to Title Four, Articles I through XII, which has not been published shall require a two-thirds majority to be adopted at the same communication at which it has been made.

Proposed Legislation:

Part 4. Amendment of Grand Lodge By-Laws.

a) Required Procedure. No alteration or addition shall be made to Title Four, Articles I through XII of these By-laws and Regulations unless proposed in writing, signed by five (5) members of the Grand Lodge, and published by the Grand Secretary in Grandview. Publication shall be at least thirty (30) days prior to the membership voting on the amendment, and shall require a majority vote of the membership for adoption.

[b) Procedure Without Publication. (DELETED)]

Interpretive Statement:

The revision requires publication of all proposed legislation in Grandview, making current subparagraph b) unnecessary. The additional requirement that publication be no less than thirty (days) before the vote ensures that members will have due and timely notice of all proposed changes. Publication in the New Jersey Freemason may still be done; however, this form of notice would be secondary and avoid the possibility that unexpected delays in publication of that magazine would not allow time for due consideration of the legislation by the membership. The requirement that five (5) members sign the proposed legislation is the same as the requirement found in TITLE THREE, ARTICLE I, SECTION 3 for signatures submitted in support of proposals to amend the Grand Lodge Constitution.

TITLE FOUR, GRAND LODGE BY-LAWS ARTICLE XI: Trial of Charges Section 9. Appellate Process Part 1. Appeal from Decision of Trial Panel

Current Legislation:

Part 1. Appeal from Decision of Trial Panel.

a) Right of Appeal. The accused, the accuser, or any member of the lodge which received the charge, may appeal to the Grand Lodge from any action of the Trial Panel of such lodge. Such appeal must be perfected before the next annual communication of the Grand Lodge if at least three months intervene between such action and such communication; otherwise to the next succeeding annual communication of the Grand Lodge unless otherwise ordered by the Grand Master.

Proposed Legislation:

Part 1. Appeal from Decision of Trial Panel.

a) Right of Appeal. Only the accused or the accuser may appeal to the Grand Lodge from any final judgment of the Trial Panel; or from a punishment imposed by the lodge receiving the charge, as follows:

- (1) The accused may appeal the final judgment or punishment imposed on the basis of error in finding of Masonic law, or in finding of fact(s) supporting the judgment and/or punishment; illegality; misconduct in the proceedings; or other factor reasonably bearing on the fairness of the proceeding, the judgment, or the punishment imposed.
- (2) The accuser may appeal the final judgment only if such appeal is expressly provided for in these By-laws or if the punishment imposed is illegal. Absent a specific

provision allowing for the appeal or for illegality, the Grand Lodge shall promptly dismiss the appeal filed by the accuser.

b) An appeal must be perfected before the next annual communication of the Grand Lodge if at least three months intervene between such action and such communication; otherwise to the next succeeding annual communication of the Grand Lodge unless otherwise ordered by the Grand Master.

Interpretive Statement:

The standard for conviction of a Masonic offense is high: Proof Beyond a Reasonable Doubt. This is the same standard applied by our State's Courts in a criminal case. It follows that State procedural rules for criminal cases could be informative and provide guidance for our Masonic appeals process.

In *State v. Hyland*, 238 N.J. 135 (2019), for example, New Jersey's Supreme Court observed that, in the matter then before it, the State had authority to appeal a sentence only where there was express authority to do so, or if the

sentence imposed was illegal. This general rule is followed in the proposed By-law revision, which limits the accuser's right to appeal a punishment (sentence) unless the By-laws specifically allow it or where the punishment imposed is illegal. By way of further guidance, the Hyland Court noted two categories of illegal sentences; those that exceed the sentences (punishments) authorized for a particular offense and those sentences that are not authorized by law.

By thus limiting the accuser's right to appeal, the revised By-law strengthens the accused's protection against double jeopardy, which could occur if the accuser was allowed to take an appeal after an acquittal or because he was dissatisfied with the severity of the punishment. If allowed, such an appeal would have the effect of prosecuting the accused twice for the same alleged offense. Further, and as revised, the By-law protects the due process rights of the accused to appeal by specifically authorizing appeals based on error, illegality, misconduct, or other factor(s) reasonably bearing on the fairness of the proceeding and punishment imposed.

Honoring WB Vincent P. "Mickey" McMann PM

On June 26, 2025, Woodstown Lodge as well as the New Iersev Masonic community lost one of its most cherished Brothers when Vincent P. "Mickey" McMann, 81, passed away peacefully at home. Born in nearby Salem on September 17, 1943, Mickey's life was defined by steadfast dedication—to his family, his friends, and the countless organizations he uplifted over four decades of tireless service. The youngest child of Vincent and Louise (Rescola) McMann, Mickey grew up in Salem alongside his three older siblings. After graduating from Salem High School in 1962, he met Donna Rae Allen at a local dance hall—a meeting that blossomed into a marriage lasting nearly 39 years. From that day forward, Donna remained his steadfast partner, and later in life, Mickey's devotion was evident when he retired early from DuPont to care for her during her illness. Shortly after high school, Mickey embarked on what would become a nearly 40-year career at DuPont's Penns Grove plant. Rising through the ranks to retire as a Master Electrician in 2001, he was respected not only for his technical expertise but for his generosity of spirit. Even in a bustling industrial environment, Mickey never missed an opportunity to offer encouragement—or share a homemade pie. There is no one have equaled Mickey's service as Secretary of Woodstown Lodge No. 138. For more than forty-two years, he meticulously recorded each meeting, welcomed and mentored new brethren, and lived the Masonic principles of Brotherhood, Relief, and Truth. His distinction as New Jersey's longest-serving lodge secretary stands as a testament to the deep trust and respect he inspired among Freemasons throughout the State of New Jersey. Mickey's work extended well beyond the lodge. He was a familiar face at Pennsville Little League concession stands, cheering on young athletes as

enthusiastically as any parent. Through generous giving to the Arc of Salem County and other nonprofits, he quietly supported those with developmental disabilities. Whether at a youth baseball game or a Civil War reenactment in Gettysburg, his warm greeting and willingness to lend a hand turned strangers into friends. Life with Mickey was never dull. He was the proud owner of a striking 1965 Mustang GT fastback—his "thrill ride" of choice—yet he was equally thrilled by simpler pleasures: sampling fresh fruit from the local farm stand, singing Motown classics in his rich baritone, or braving the Tower of Terror at Disney. Ever the early arriver, he would appear at gatherings before dawn's first light, eager to help set up and share his trademark sense of humor. Mickey cherished his family. He often said nothing brought him greater joy than moments spent with his son Michael, his daughter in law Stacey and granddaughters Sophia and Naomi and was affectionately named Papa Mickey whether swapping stories or making new memories. His orderly nature and fastidious care transformed their home into a haven of comfort and laughter. Vincent P. "Mickey" McMann lived life with a perpetual twinkle in his eye—spreading kindness, knitting communities together, and savoring life's simple delights. With those capable hands and that generous heart, he forged friendships everywhere he went (often over a slice of pie). Anyone who crossed his path will tell you Mickey's warmth could outshine the darkest of days. His spirit lives on in every smile he inspired and every story he told.
